Consider Resolution and Certificate of Incumbency

Manager Gianquinto reported that the sale of bonds associate with the Water Banking Revenue Refunding Bond Series 2019A in the amount of \$70,960,000 was successful. The annual debt savings will amount to approximately \$654,000 per year. The transaction is expected to be completed on October 30, 2019. Discussion followed on details of interest rates, costs and payment schedules.

Due to a change of Board officers, a Resolution to Amend the Sun Trust Bank SWAP Agreement is needed, giving authorization to Board officers and the General Manager to complete the transaction.

On motion by Director Wegis, seconded by Director Portwood, the Board unanimously authorized an Amendment to the Sun Trust Bank SWAP Agreement in the form of Resolutions and Certificate of Incumbency.
