## MINUTES OF THE SPECIAL MEETING OF THE BOARD OF DIRECTORS OF THE SEMITROPIC, BUTTONWILLOW, POND-POSO AND WILDLIFE IMPROVEMENT DISTRICTS OF SEMITROPIC WATER STORAGE DISTRICT

Convened at 1:00 p.m. on Tuesday January 22, 2019

The Special Meeting of the Board of Directors was called to order by President Wegis on Tuesday, January 22, 2019, at 1:00 p.m. at the offices of the District, 1101 Central Avenue, Wasco, CA 93280.

## Consider Exchange/Banking Agreement with Shafter-Wasco Irrigation District

General Manager, Jason Gianquinto, reported that Shafter-Wasco Irrigation District (SWID) has 3,000 acre-feet of CVP recirculation water in San Luis Reservoir that must be delivered by February 28, 2019. If the SWID water is not delivered by the end of February, then SWID will lose the water. Therefore, SWID has asked Semitropic to enter into an agreement to assist in the delivery of this water to storage prior to the end of February on a 50-50 split of water and delivery costs. Discussion followed.

On motion by Director Fabbri, seconded by Director Tracy, the Board authorized execution of a Water Transfer/Exchange Agreement between Semitropic Water Storage District and Shafter-Wasco Irrigation District; and determined entry into the agreement was exempt from CEQA review under CEQA and authorized staff and legal counsel to file a CEQA Notice of Exemption with appropriate agencies.

## **Closed Session**
