President Wegis welcomed everyone and noted a quorum.

Update and Discussion on Cal Water Fix & Water Management

General Manager, Jason Gianquinto, stated that today's meeting was a follow-up to previous landowner meetings to further discuss options and a timeline on the Cal WaterFix.

It was reported that the Cal WaterFix Project will be under a Design-Bid-Build concept. The Project is currently at 20% design stage. The projected costs are between \$13M to \$17M. Metropolitan Water District (MWD) is a major part of the program and will keep pretty close tabs of the costs. The Biological Opinion should be out next week as well as the Record of Decision and Notice of Determination.

Discussion followed regarding

- 1) Financing of the Project with possible Federal and State funding.
- 2) Methods for contracting for Cal WaterFix Participation

- a. A proposed amendment to the existing landowner agreements to include option for Cal Water Fix Participation
- b. Development of new agreement for California Water Fix Participation (separate from existing contract water agreements). Would require development of scope of contract and definition of benefits.
- 3) Debt Service, decide method of payments for Cal Water Fix Participation
 - a. New Assessment: would Require Prop. 218 compliance
 - b. By Contract with willing landowners
 - c. Hybrid: combination of assessment for portion of benefit realized by District on behalf of all landowners paying the assessment and Contract with willing landowners for incremental water supply benefit
- 4) Estimated Participation of all landowners
- 5) True costs of the project

The meeting was discussion only and no action was taken.
